**RENTAL AGREEMENT**

- ❖ I accept that all equipment was received in good condition and agree to return it all in equally good condition.
- ❖ I agree that all persons were provided with age appropriate life-saving devices (one life-preserver or cushion per adult, one life-preserver per child under 14).
- ❖ I agree that all children 6 and under must wear a life-preserver at all times
- ❖ I assume all risk of loss or damage of equipment rented until returned
- ❖ I assume all risk of accident or injury to myself, my party, and others
- ❖ I agree to pay LATE CHARGES of \$15/one-half hour after 6pm
- ❖ I understand that no alcoholic beverages or swimming are allowed on the premises, that no glass containers are allowed in the canoes/kayaks, and that shore fishing is not allowed.
- ❖ After portaging the Milford Dam, I agree that UNDER NO CIRCUMSTANCES will I paddle back towards the dam. I understand that the turbulence of the water at the dam is strong enough to sink a canoe/kayak and cause serious injury and/or death.

**RELEASE OF LIABILITY**

In consideration of being allowed to rent or launch any canoe or kayak, or any related event or activity, from Village Canoe Rental, I, the Undersigned, acknowledge and agree that:

- ❖ The risk of injury from the activities involved in canoeing or kayaking is significant, including the potential for permanent paralysis and death, and while particular skills, equipment and personal discipline may reduce this risk, the risk of serious injury or death does exist; and,
- ❖ I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume FULL RESPONSIBILITY for my participation; and
- ❖ I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Company immediately; and
- ❖ I, for myself and on behalf of my heirs, assigns, personal representative and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS VILLAGE CANOE RENTAL, its owners, officers, officials, agents, employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owner/lessors of premises used for the activity ("releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, WHETHER ARISING FROM NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest permitted by law.
